

Terms of Entry

1. The Promoter is Sports & Entertainment Limited (the 'Promoter'), ABN 28 078 727 938, Level 3, 243 Liverpool Street, East Sydney NSW 2010.
2. The promotion will operate at each round of the 2011/12 Kellogg's Nutri-Grain IronMan and IronWoman Series, at the following locations and times (the 'Promotion Period'):

4. To enter, a sign must be made showing a positive message of support for a Round listed in clauses 2(a)-2(f) of these terms of entry and/or a competitor in one of the Rounds. The sign must be displayed during one of the Promotional Periods.
5. The competition winner will be the person judged by a representative of the Promoter to have made the best sign. The winner will be decided by the Promoter's representative in his/her absolute discretion and the decision will be final.
